Weight Limit Posting Issues

General Information about weight limits

Weight limits in Vermont are automatically the following, unless posted otherwise:

- 80,000 lbs for state roads
- 24,000 lbs for class 2, 3 or 4 town highway or bridge (not wood floor)
- 16,000 lbs for any bridge with wood flood or stringers on class 3 or 4 town highway
- 20,000 lbs for any bridge with wood floor or stringers on class 1 or 2 town highway

All roads are suitable for all vehicles unless posted otherwise

Need signs to say weight limit when move from state road to town road. These signs can be installed by VTrans.

Class 1 weight postings would need to be approved by VTrans, and have a safe alternative route. 23 VSA 13(3) § 1042 - http://legislature.vermont.gov/statutes/section/23/013/01042

Can only have one weight limit for the entire length. This means that if part of a through road has a notable weight restriction (eg bridge), the entire road would have to have that limit, unless there was another road out of the area to avoid the bridge.

Certificate of postings is needed if weight limit is not normal (24,000 lbs for town roads) – would be on file with:

Emergency services can use any road despite postings

- Emergency service vehicles exempt 23 VSA 13(15) § 1399 http://legislature.vermont.gov/statutes/section/23/013/01399

Agricultural service vehicles (eg milk trucks) can use any road despite postings, although they must choose the quickest route causing least damage (eg least mileage on unpaved roads and weight restricted roads).

Fuel, trash and utility vehicles are not exempt from road postings. (Although it could be seen that an emergency oil delivery in the winter is an emergency.)

While you cannot stop oil trucks making deliveries on roadways, if there is an issue of weight you could require that oil company only to carry the oil needed specifically for that house.

Logger vehicles often 80,000 – 90,000 lbs, and sometimes more

Can specify load per vehicle type – although unusual.

Be very careful not to discriminate against or show favoritism for any particular vehicle.

Permits

Need to have permits available otherwise all vehicles have permission to drive on all roads

Permits need to be renewed annually - 23 VSA 13(15) § 1400a - http://legislature.vermont.gov/statutes/section/23/013/01400a

A variety of people have authority to issue permits – written or verbal - Selectboard/ Trustees/ Legislative Body. But written permits are easier for the DMV to enforce

Permits can include:

- Hours of operation
- Weight Limits on specific roads
- Conditions including "unless otherwise posted for frost/mud season"
- Some cost recovery for damage 23 VSA 13(15) § 1400a http://legislature.vermont.gov/statutes/section/23/013/01400a

Bonding

Can require a bond in case of road damage (eg for crane)

Could bond for mud season – a good disincentive!
